Requirements of trailers : - Double axle with 15 inch tyres

- Run-in brake mechanism

- Caravan hook to hook-up with bakkies

- In accordance with the relevant Roadtraffic Act

Load capacity : Adequate to carry a full watertank of 1500lt plus a



waterpump combination for refilling

Waterpump : Low pressure high volume pump with 50mm inlet and 50mm outlet driven by a petrol engine

The waterpump combination must be fitted with a 4 metre X 50mm suction hose (to be disconnected after filling) to withdraw water from a resource to fill up the watertank. The waterpump combination must be connected to the watertank to withdraw water from the tank to refill the fire-fighters.

Provision must be made for priming the waterpump.
